Today's topic was inspired from a dialogue with an associate about an article by Mohamed El-Erien and the Serenity Prayer. It sent me back to the Book of Psalms. A single word in the prayer overshadows all but the words of God. "Wisdom."

Wisdom¹ is a deep understanding and realizing of people, things, events or situations, resulting in the ability to choose or act or inspire to consistently produce the optimum results with a minimum of time, energy or thought.

The Serenity Prayer -- Reinhold Niebuhr:

"Optimum results with a minimum of time, energy or thought." The definition fits well with business models but miserably fails God's moral model.

Many business models have had influence upon the global lawmakers whose interns have written laws that favor the business model over God's model. This is where real wisdom needs to be applied. Do the believers in God's model bend over and take the business model up the gizmo without a fight? Hell no! The business model preys upon the godly in hopes that the godly would go home and pray for God's intervention. This belief scenario fits well within a one-dimensional
